

ORDINANCE NO. 1273

AN ORDINANCE AMENDING DRAPER CITY MUNICIPAL CODE SECTION 19-1-050 (GIFTS; USE OF OFFICE FOR PERSONAL BENEFIT PROHIBITED) TO BE CONSISTENT WITH UTAH CODE 10-3-1304 (USE OF OFFICE FOR PERSONAL BENEFIT PROHIBITED)

WHEREAS, the Utah State Code changes from time to time, and;

WHEREAS, the Draper City Municipal Code 19-1-050 has minor inconsistencies with Utah State Code 10-3-1304, and;

WHEREAS, the Draper City Council desires to have the City and State Code be consistent.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:


Section 1. Approval. The City Council hereby approves Ordinance #1273 adopting Utah Code Section 10-3-1304 by reference in City Code Section 19-1-050 as shown in Exhibit A attached hereto and incorporated herein by reference.

Section 2. Severability. If any section, part, or provision of this Ordinance is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts, and provisions of this Ordinance shall be severable..

Section 3. Effective Date. This Ordinance shall become effective immediately upon publication or posting or 30 days after final passage, whichever is closer to the date of final passage.
